RATE HEARING:

The Board shall review the rates, fees and charges, except the City User Fee, of services rendered by PEU. Participation, input and review from the public is welcome.

The Board DOES NOT PLAN TO consider a rate increase during this rate hearing. Any decision of the Board concerning rates is subject to review & approval by the Page City Council, which has final authority to approve PEU rates. The hearing is open to the public. Any person (an Intervenor) who desires to be heard at the hearing must provide notice in writing to the PEU Board at least two (2) business days before the hearing. This notice must contain the name and address of the Intervenor and the name and address of Intervenor=s legal counsel (if any legal counsel will appear at the hearing on behalf of the Intervenor). Intervenor=s must provide eight (8) copies of any document(s) that the Intervenor wishes the PEU Board to consider in relation to the rate hearing.
